Thank you for your interest in Marshfield Country Club's (MCC) Trial Membership Program. This membership allows you to join MCC for one year and enjoy all the benefits for the entire 2012 season without paying an initiation fee. At the end of the year you can opt to join as a full privileged voting member by paying the Club's then current initiation fees – or you can choose not to join. There are a limited quantity of Trial Memberships available and they are on a first-come registration basis – meaning the membership could fill up fast. Please note that the application and deposit check must be submitted to be registered.

Should you choose to apply for the Trial membership, here are some important things to note:

1. There is no initiation fee or bond fee for this 1 year membership.
2. An applicant can choose an individual membership, add a spouse or include the entire family. See the Categories and Privileges attachment for more details.
3. The Trial Membership includes full House privileges.
4. The application must be completed and submitted along with a \$1000 deposit check. See the attachments for details. That deposit will be credited towards the 2012 dues should your application be accepted – or it will be refunded in the event that the membership is full or the application not accepted.
5. In the event you are not familiar with two members for proper sponsoring, let me know the circumstances and we'll try to help out.
6. For all Trial Members, the remaining dues for 2012 will be billed over several months – similar to all members.
